If Product is determined by TRUE HARBOR, LLC to be defective, TRUE HARBOR, LLC will replace the Product in question with new Product of the same or equivalent value at no charge.

TRUE HARBOR, LLC warrants its Product against fading, breaking, corrosion, rust, or insect infestation under normal use and service.

THIS LIMITED WARRANTY does not cover damage resulting from accident, unreasonable use, neglect, alteration, improper service, improper installation, acts of God or any other causes not arising out of defects in materials or workmanship. Additionally, this warranty does not cover costs of labor, freight, taxes or other expenses associated with installation, removal or reinstallation of product.
